EXECUTIVE ORDER NO. 91 Series of 2019

AN EXECUTIVE ORDER DESIGNATING MS. FLORALYN RAMAT-MENDOZA AS GENDER AND DEVELOPMENT (GAD) FOCAL PERSON OF THE MUNICIPALITY OF SAN MARCELINO, PROVINCE OF ZAMBALES

WHEREAS, as required by the Magna Carta of Women (MCW) and following the Philippine Commission on Women (PCW) Memorandum Circular 2011-01, Guidelines for the Creation, Strengthening and Institutionalization of the Gender and Development (GAD) Focal Point System, all agencies should have an institutionalized GAD Focal Point System (GPFS);

WHEREAS, according to Joint Memorandum Circular No. 2013-01 (Guidelines on the Localization of the Magna Carta of Women), Local Officials and Employees shall be responsible in promoting and ensuring that gender and development is mainstreamed in local policy making, planning, programming, budgeting, implementation, monitoring and evaluation. In this regard, LGU shall ensure that their GAD Focal Point System (GPFS) or similar GAD mechanisms are in place, fully functional and members have the capacity and influence to promote gender mainstreaming pursuant to Section 37 of the MCW Implementing Rules and Regulations (MCW IRRI);

WHEREAS, all LGUs are mandated by JMC No. 2013-01 to establish and/or strengthen their GFPS or similar GAD mechanisms to accelerate gender mainstreaming within their localities. Furthermore, It is stated that the Local Chief Executive/s (LCEs) shall sign appropriate issuances to institutionalize the establishment, reconstitution and/or strengthening of the GPFSs in their respective LGUs.

NOW THEREFORE, by the powers vested in me by law, I, ENGR. ELVIS RAGADIO SORIA, Local Chief Executive of the Municipality of San Marcelino, hereby designate MS. FLORALYN RAMAT-MENDOZA, as Gender and Development (GAD) Focal person, with following stipulations:

SECTION 1: DUTIES AND FUNCTIONS

- Formulate long-term, medium term and annual integrated gender and development plans and policies.
- 2. Submit or develop a comprehensive developmental program responsive to the needs and situation of the women sector of the municipality.
- 3. Identify problem confronting the women sector and formulate programs, projects and activities (PPAs that uplift their condition.
- 4. Monitor and evaluate the implementation of national or local programs and projects
- Promote and support the establishments of consultative mechanisms which shall provide for q continuing dialogue between the government and women sector
- 6. Maintain and update data bank through the conduct of primary and secondary data gathering activities
- 7. Determine the existing gender issues and draws up objectives, targets and strategies addressed to the GAD Focal Point System

- 8. Estimate the resources needed in implementing the GAD Plan
- 9. Conduct seminars on gender sensitivity and gender responsive planning.
- 10. Perform such other functions and exercise such other powers as may be provided by law or competent authority.

Section 2. EFFECTIVITY.

The GAD Focal Person shall exercise its powers and duties effective immediately and shall be in force until this Order is revoked or suspended.
